CMBABU Summer Assignor's Report 2021 (926 games)

Our summer baseball is changing. Legion and junior legion appears to be falling apart. Babe Ruth is shrinking each year.

MSBL is shrinking as well. 25 of the Men's League were the college league that I categorized as Men's League. The remaining teams in the MSBL are Winthrop, Bethel, Rumford, and a new team added in Bath.

AAU is growing each year. This has had an impact on Br. AAU plays exclusively on weekends. The best player from a given location are not available if they play AAU. The same is true for junior legion. The wooden bat league run out of Portland area has all but eliminated any legion teams south of Topsham/Brunswick and also Winthrop MSBL (Kennebec/Somerset did not want).

The good news for umpires is that the total number of games is still growing. The bad news for the summer assignor is that the number of umpires continues to shrink.

You will see a large disparity in the number of games per official. This is totally based on availability and in a few cases, ability.

There were 205 games cancelled due to not enough players and weather. Assigning is becoming more of an issue.

Thankfully, we have some officials that are willing to umpire whenever asked. **Cooperation from officials this year was outstanding.** 26 umpires worked 20 or more games.

The summer rates stayed the same last year, but given the price of fuel, and no mileage fee to the teams, I would suggest that the fees go up by five dollars per game per umpire.

There were no playoff funds used for summer baseball. The availability of umpires did not allow putting three or four-man crews on any games.

Our board members traveled outside of our geographic area to do games at Little Fenway in Oakland, and Little Wrigley in Waterville, for AAU and The Ball Park in OOB for the post season for the over 45 and over 60.

Issues:

We need to inform leagues as soon as possible if there are going to be fee changes.

We need new members.
